This Post Graduate course in Systemic Therapy and Family Therapy has training program accreditation from the Australian Association of Family Therapy (AAFT).

Who is this training for?

This training program is designed for clinicians interested in extensive skill development and in-depth learning of the theoretical underpinnings of both the early and current approaches to Systemic Therapy and Family Therapy. Upon satisfactory completion of the course, trainees are eligible to apply for clinical membership with AAFT. You'll need a previous qualification in the helping professions and be currently working as a counselor.

Brief Overview

Course Structure.

This course has 2 levels: The Foundation Year for 2025 will run from February to December, meeting weekly for 5 hours on a Thursday afternoon, from 12.00pm to 5.00pm, over 4 X 8-week terms. Each term will start with a 2-day intensive on a Friday and Saturday, 9.30 am to 4.30pm.

The Advanced level for 2025 also runs from February to December on Tuesdays, 12.00pm to 5.00pm, over 4 X 10-week terms.

Course Content

- The course content covers and integrates Systemic Therapy, (Post Milan) Narrative and Solution Focused Therapy within a social constructionist and dialogic framework.
- There is an emphasis on understanding the ideas and linking them with practice.
- Plenty of skills development practice and supervised clinical work in the Low Fee Clinic.
- Detailed learning and reflection on practice via regular reviews of video recordings of clinical work undertaken in the Low Fee Clinic.
- Learning how to participate in reflecting teams.
- Discussion of weekly articles.
- Exploring maps of practice to help with learning and application of systemic skills.
